President Noble called the meeting to order at 7:00 pm. The meeting was noticed per WI s.s.19.84 and was declared a legal meeting. Rolf Call: Bartnick, Burke, Lee, Noble, Pauli, Stewart, Tomlinson.

Motion by Pauli/Burke to approve the minutes of the Board of Education meetings for May 17, 2021. Motion carried with all present voting yes.

Administrative Reports

- Mr. Fischer informed the board of a busy completion of the 20-21 school year for the special education team as they
 helped students prepare for their next transition, as well as their work outside of the regular school schedule including
 coming in to work with students on virtual Wednesdays and spending additional time in professional development.
- Mr. Hausser highlighted for the board two of the year end events including the elementary school literacy night and a 4th grade celebration for families. He shared that the community tours are going well, summer school is off to a good start, and the elementary staff is engaged in professional development learning the new elementary math curriculum.
- Dr. Pritzl informed the board of the successful effort to involve more middle school students in summer school math and
 reading skill classes and attributed much of it to the work of the summer school principals. He also shared the
 appreciation and excitement for the additional room renovations and new furniture in the middle school classrooms.
- Dr. Hoernke updated the board on the successful graduation events and thanked the parents of the senior class for their help along with Mrs. Heintz and Ms. Milkent who also devoted extra time and effort. SCHOOL DISTRICT OF POYNETTE SPECIAL MEETING OF ELECTORS JULY 1, 2021

POYNETTE HIGH SCHOOLIMC 108 N. CLEVELAND ST., POYNETTE WI 53955

President Noble called the meeting to order at 6:00 pm.

Motion by Lisa Hazard/Jerry Burke to nominate Jeff Noble as chairperson. Motion carried with all present voting yes.

Administration presentation of information about Unusually Hazardous Transportation Zones:

Dr. Shappell explained the purpose of the meeting which is to decide the distance for bus pick up from home to school.

- By state statute the distance for eligibility for transport is a two mile default from home to school unless specifically stated in board policy (determined by the electors at the School District Annual Meeting) or unless deemed an unusually hazardous zone. The definition of "unusually hazardous" zones include areas that are a safety issue for students, such as areas that have no sidewalks.
- State statues dictate that electors may modify the transportation rule of two miles via a special meeting. Since the
 district has had changes in the existing hazardous zones due to the Village of Poynette's installation of sidewalks,
 one of the unusually hazardous zones have been eliminated in the northwest area of the village by the elementary
 school.
- The electors are allowed to differentiate between age groups if desired when reviewing the transportation policy.

Presentation and discussion about possible changes to Transportation Policy to indicate distance district will provide transportation.

- Maps were shown of village including streets and sidewalks as well as the location of school buildings
- Distances were reviewed from different points within the village to the various schools
- Walking routes were discussed relative to crossing guards locations

The School District Administrative recommendations are the following for maximum walking distances for students:

- 1. Elementary students (Grades Kindergarten to 4th), approximately .8 to .75 miles
- 2. Middle School/High School students (Grades 5th to 12th), approximately 1 mile

Discussion:

The golf course area will always be a hazardous busing zone for elementary due to crossing State Hwy. 51 as there is only a crossing guard at Hwy. 51 and Sewart Street (but no one at the intersection of Hwy. 51 and North Street).

The mobile home estates will always be hazardous for elementary due to lack of sidewalks and lack of bus accessibility due to the roads there. The middle school and high school students from that area walk to school.

Meadow Lane and Valley View is close enough to the sidewalk areas that it is deemed to not be hazardous per the Columbia County Sheriff Department.

Elementary students - .8 covers areas to around the Rowen Creek crossing on Main (bus those south of that) MS/HS students - 1 mile would include walking from Colby Blvd. and the Golf Course area.

Motion by Jeff Noble/Jerry Burke to modify policy 8600 to establish a busing distance of .8 for elementary age students and 1 mile for Middle School and High School students. Motion carried by a show of hands with all present voting yes (11 votes).

COVID and Return to Learn Updates

After a period of relative calm, it seems local COVID infection numbers are ticking up a bit. At this point it is something we'll watch. Last year demonstrated that districts must be flexible and resilient. We'll let local circumstances and CDC/DHS guidelines determine our plan.

- If levels stay close to where they are now, we'll start the year with approved face coverings being
 "recommended but not required" for students. We anticipate having a continuum for masking mitigation
 and staff and families should be prepared for short duration requirements in response to local levels of
 spread.

Educational options for students who are enrolled in the Poynette School District that involve part-time attendance at an educational institution other than a school of the Poynette School District include the following:

• Part-Time Open Enrollment: Beginning in the 2018-19 school year, a student who is enrolled in a public high school may attend a public school in a nonresident school district on a part-time basis in accordance with section 118.52 of

the state statutes (the part-time public school open enrollment law). A student may attend no more than two courses at a time in a nonresident school district under this law.

- The Early College Credit Program (formally Youth Options). which provides opportunities to apply for approval to take courses at certain institutions of higher education. allows Wisconsin public and private high school students to take one or more course(s) for high school and/or college credit. Under this section, "institution of higher education" means an institution within the University of Wisconsin System, a tribally controlled college, or a private, nonprofit institution of higher education located in the state. While technical colleges are not eligible institutions under the new program, pupils that have completed 10th grade will continue to have the option to take courses at technical colleges through a separate statute, 38.12(14). (From DPI website)
- Additional educational options for children who reside in the District that involve full-time enrollment/attendance at a school, program, or other educational institution that is not a school or instrumentality of the Poynette School District include the following:
 - High school students meeting certain age and other eligibility requirements may be permitted to attend a technical college or certain other programs for the purpose of completing a program leading to the student's high school graduation or to a high school equivalency diploma.
 - Full-time Open Enrollment involves physical attendance in a public school of a nonresident school district
 or attendance through a virtual charter school that is associated with a nonresident school district.
 - A child with a disability who meets the program's specific eligibility requirements may apply to attend an
 eligible, participating private school under a scholarship awarded through the state's "Special Needs
 Scholarship Program," as established under section 115.7915 of the state statutes.
 - o Enrollment in a private school of the family's choosing (at the family's own cost, as applicable).
 - There is one DPI recognized private school within the district's boundaries: Stepping Stones Learning Center, 1199 N US Highway 51 Poynette WI, grades 4K-12
 - Enrollment in a home-based private educational program as provided under state law. Educational options
 for children who reside in the Poynette School District but who are enrolled in and attending a private
 school, or home-based private educational program include the following:
 - Such students have the opportunity to attend summer school classes/programs offered in the District.
 - Private school students in the high school grades have the opportunity to apply for approval to take up two courses per semester in a District school, pursuant to section 118.145(4) of the state statutes.
 - Students who are enrolled in a home-based private educational program have the opportunity to:
 - Apply for approval to take up two courses per semester in public schools as provided under section 118.53.
 - Participate in District interscholastic athletics and other District extracurricular activities as provided under section 118.133.

Procedures for Virtual/Online Learning

The School District of Poynette strives to offer coursework and instructional delivery that meets the needs of all students. The School District of Poynette may offer a virtual or online program for students in grades K-12. The District will ensure that courses will be taught by teachers who have or are able to obtain an appropriate WI teaching credential.

The School District of Poynette is affiliated with the JEDI Online Network, which is a consortium of school districts providing online learning opportunities.

Online courses may or may not meet the academic eligibility requirements established by the National Collegiate Athletic Association (NCAA), and it is the student's responsibility to verify a course's NCAA status if that is a concern for the student. JEDI grades appear on transcripts and permanent records.

Full-Time Virtual Enrollment

Resident students* in grades K-12 wishing to enroll full-time in the JEDI virtual school program as an alternative to traditional programming may request a meeting with the building principal, school counselor, parent(s)/guardian(s), and a JEDI representative.

Open enrolled students must physically attend for at least two years (four complete semesters) before they are eligible for full-time JEDI virtual instruction.

Students enrolled in full-time virtual school are subject to policies and guidelines of both JEDI Virtual School and the School District of Poynette.

The building principal will approve or deny requests for full-time virtual instruction by taking into account at least the following factors:

- 1. The reason(s) for the student's interest in the course(s), including any exceptional interests, needs or requirements that the student may have:
- The likelihood that the student will succeed in the online learning environment relative to other options, which may include the District's assessment of factors such as the student's academic record, the student's behavioral records, the student's prior experiences in different educational settings, etc.;
- 3. The student's eligibility for the specific course(s) and academic readiness to be successful in the specific course(s) (e.g., the student has met applicable prerequisites);
- 4. Whether taking the course(s) would be likely to interfere with the student's progress toward timely graduation from high school;
- 5. Availability of the course and seats in the course;
- 6. Recommendation(s) of teachers and other staff;
- 7. Recommendation(s) of the student's parent(s) or guardian(s);
- 8. Student interview:
- 9. If the student applies to take online courses under a proposed schedule that would jeopardize the student's full-time status or result in the student receiving more credits in any semester or term than could otherwise be earned by taking a full daily schedule of classes, then the building principal, or designee, must conclude that the student has exceptional needs or requirements that clearly and convincingly demonstrate that such a schedule is the most appropriate educational program for the student.

The principal's denial of any request for full-time virtual enrollment online course is appealable to the District Administrator first. If the District Administrator denies the request, the student or parent/guardian may further appeal the denial to the Board as provided by state law and Board policy. School officials will then approve or deny the request for full-time JEDI enrollment. If denied, the appeals process identified above will apply.

Full-time JEDI virtual school students must complete all Poynette Schools graduation requirements in order to receive a diploma from Poynette High School.

A parent contract is required for full-time virtual enrollment. Students who withdraw from a virtual course or full-time virtual enrollment after 10 days will be held financially liable for the cost of tuition. Students who withdraw after the final allowable date may have a failing grade on his or her permanent transcript.

Grades earned in a virtual setting will become part of the student record.

Tuition will be paid by the district for full-time resident* students. Families are responsible for tuition after the withdrawal date passes.

Individual Online Course Requests

High school students (grades 9-12) may apply for approval to take individual online courses on a voluntary basis. Middle School may be approved for individual courses under unique and extenuating circumstances at the discretion of the principal and school district. Students wishing to take an online course(s) must have a parent or guardian permission to submit an application. The application process:

- 1. Submit a written request to the student's school counselor, building principal, or other designated staff; and/or
- 2. If applicable, present the request to the student's individualized education program (IEP) team so that it can be considered in connection with the student's IEP.

A student may not take an online course that is comparable to a course that the student has already taken and for which the student has already received academic credit for the purpose of either (a) replacing the grade that the student previously received or (b) obtaining additional academic credit.

Students will follow the process described below to request enrollment in an individual online course:

- 1. Students and parent(s)/guardian(s) will discuss online course options with a school counselor or other District representative first.
- 2. If applicable, a representative of the virtual program will review a syllabus and expected course pacing for each class of interest to determine the best options for the student and report to the school counselor and the family regarding their findings.
- 3. Students will indicate their intention to enroll in an individual online course and complete an application during the normal course scheduling process for the following academic year.
- 4. If applicable, the virtual program representative or district designee will provide registration materials to families indicating individual course options with detailed instructions.
- 5. The student and parent/guardian will complete the individual course registration form and submit it to the counseling office no less than two weeks prior to the beginning of the term for which the student wishes to enroll in the class.
- 6. Enrollment in online courses at other times of the year due to individual circumstances, such as illness or expulsion, will be decided on a case-by-case basis.

- 7. Students may enroll in up to two online courses per semester.
- 8. Online summer courses are at the discretion of the district.

The building principal will approve or deny requests for an online course by taking into account at least the following factors:

- 1. The reason(s) for the student's interest in the course(s), including any exceptional interests, needs or requirements that the student may have;
- The likelihood that the student will succeed in the online learning environment relative to other options, which may include the District's assessment of factors such as the student's academic record, the student's behavioral records, the student's prior experiences in different educational settings, etc.;
- 3. The student's eligibility for the specific course(s) and academic readiness to be successful in the specific course(s) (e.g., the student has met applicable prerequisites);

If a student receives approval to take an online course, the student's schedule may include a designated time during the normal school day during which the District will provide the student with access to the technology resources that are necessary for the student to access the online course.

Virtual Tuition

The District reserves the right to limit enrollment in JEDI Virtual School (full-time and/or individual courses) for budgetary purposes.

The fees and timelines involved with virtual instruction are determined by the JEDI Virtual School.

The District will pay for all approved and successfully completed coursework. If a student withdraws from a course within the approved timeline, families will not be charged tuition. Full-time students who withdraw within the timeline will be provided an appropriate in-person schedule.

Students who withdraw from virtual coursework after the withdrawal deadline, will be charged the current tuition rate. Please contact administration for a current JEDI Virtual School rate chart.
