BOARD OF EDUCATION MEETING MONDAY, SEPTEMBER 13, 2010 – 7:00 P.M. POYNETTE 1-8 IMC

President Kathleen Lucey called the meeting to order at 7:00 p.m. in the Poynette 1-8 IMC. This meeting was noticed in the September 8, 2010 issue of the Poynette Press and posted in various areas of the community. Roll Call: Present – Bender, Hoffmann, Lucey, Schernecker, Wilkinson. Absent – Burke, McIlrath Administration: Wolfe, Mair, Sutton, Chittick, McCallum, Hausser. Media, Staff, and district residents were also present.

Motion by Schernecker/Bender to approve the agenda. Motion carried with all present voting yes. Motion by Bender/Schernecker to approve the August 30, 2010 minutes. Motion carried unanimously.

IN-SERVICE REPORTS:

Alan Chittick: There were 11 new students with IEP's and 11 students with IEP's that were present last school year are no longer enrolled in the district.

Brian Sutton: Excellent MS and HS assembly speaker on making good choices. Start of school year went quite well.

Nancy Mair: The high school nutrition break has been postponed for at least one week due to computer programming needed.

Craig McCallum: Some busing issues at start of year are being addressed. HS Band made 5 summer public appearances.

Superintendent Barb Wolfe: Poynette teachers will speak on technology in the classroom at 9/29 regional WASB meeting. Preliminary count of actual students is 1143 compared with 1126 last year. **Greg Schernecker:** Indicated he will be attending the NSBA national convention next year.

COMMUNITY FORUM: Three individuals addressed issues related to the previously scheduled beer tent after the homecoming game.

DISCUSSION ON BOOSTER CLUB HOMECOMING ACTIVITY: Suggestions were made to revise current policy related to alcohol and drugs to expand language beyond employees. Schernecker raised other related issues including donations coming from sales of raffle tickets, prior summer street dances sponsored by the Booster Club, and the possibility of the Booster Club ceasing affiliation with the district.

UPDATE ON QUALIFED SCHOOL CONSTRUCTION BONDS/REFERENDUM INFORMATION: No further information is available at this time.

PRESENTATION OF SUMMER SCHOOL REPORT: There were some interesting new programs this past summer including an art class using only recycled materials. More thought is already in place for next years offerings. There were 4,169 registrations this past summer which is similar to 2009.

DISCUSSION/ACTION ON FEDERAL JOBS ACT: An individual was selected to assist with the 3rd grade. September 10 was the deadline for applications for the IMC position. Administration is still discussing other options for IMC and Educational Excellence.

DISCUSSION/ACTION ON TEACHING CONTRACTS: Bender/Wilkinson motion to approve the teaching contract with Amanda Strasser as a 3rd grade teacher at 1BS+0 as presented. Motion carried

on a roll call vote with all present voting yes.

DISCUSSION/ACTION ON TRANSPORTATION REQUEST: Bender/Schernecker motion to approve a request for an elementary student to ride the secondary bus. Motion carried unanimously.
