Media, Staff, and district residents were also present.

Motion by Bender/Schernecker to approve the agenda. Motion carried with all present voting yes. Motion by Schernecker/Bender to approve the September 13, 2010 minutes. Motion carried unanimously. Motion by Wilkinson/Schernecker to approve the Treasurer's Report. Motion carried unanimously.

IN-SERVICE REPORTS:

Craig McCallum: Faculty is working on goals at the building level. Homecoming activities including Class of 1970 reunion. Band appeared at Wo-Zha-Wa Days in Wisconsin Dells.

Superintendent Barb Wolfe: On-going bus issues are being addressed. Main speaker at superintendent's conference supported district's progress and emphasis on 21st century learning skills.

COMMUNITY FORUM: Concerns expressed about early student issues with class sizes in 3rd grade.

INTRODUCTION OF NEW STAFF: Five new teachers, two new special education assistants, and one new office person introduced themselves.

DISCUSSION OF FACILITIES USE PROCEDURES FOLLOW-UP: Mr. Hausser and Ms. Kraus met with representatives of various organizations that are the primary users of school facilities. Issues were discussed and resolved and changes were made to the facility use guidelines.

DISCUSSION/ACTION ON BOARD POLICY – ALCOHOL USE AND SCHOOL RELATED ORGANIZATIONS (FIRST READING): Discussion focused on unacceptable actions on school property by all individuals and organizations as well as reporting of actions and finances by school affiliated organizations. A proposed revised policy will be drawn up for the next meeting.

DISCUSSION/ACTION OF QUALIFIED SCHOOL CONSTRUCTION BONDS: Consulted with Bray & Associates about drainage issues at main Poynette campus as well as HVAC issues at Arlington School. Also talked with a new HVAC contractor about Arlington.

DISCUSSION/ACTION ON BEFORE AND AFTER SCHOOL DAYCARE CONTRACT PROCESS: A committee will be formed including daycare providers, administration, school board members, and parents. Schernecker and Lucey will represent the board.
